2019 APPLICATION QUESTIONS

The following information is provided to you to assist in completing the online application (<https://cbmidwest.wufoo.com/forms/lasallian-mission-opportunities-fund/>). All requests must be submitted using the online application and will not be considered if not done so.

PURPOSE/RESTRICTIONS

To grant funding to assist in advancing human and Christian religious education in the Lasallian tradition, especially for the economically poor and socially marginalized, with specific emphasis on youth.

Awards will be limited to projects or initiatives that further human and Christian education in the Lasallian tradition. Preference will be given to those projects that support the ministries in the Midwest District, promote social justice, and directly serve the financially poor, with specific emphasis on youth. These funds will not be awarded for the purchase of equipment, construction, or other capital expenditures. In addition, funds will not be awarded to support salary or scholarships or tuition assistance for current operations, but may be used to offset salary, stipends, scholarships or tuition assistance for new programs or projects. Previous receipt of an award does not guarantee renewal.

DEADLINE

The deadline to submit the online application is **March 15, 2019**.

THE FOLLOWING QUESTIONS ARE PRESENT ON THE ONLINE APPLICATION:

- Name, address, and contact person submitting the application.
- Provide a short history of the ministry/organization.
- Acknowledge evidence of being a tax-exempt ministry/organization.
- Descriptive title of the request.
- Dollar amount requested.
- Prior requests from the Midwest District and, if any, prior awards.
- Provide a narrative of how the intended project reflects the purpose of the Lasallian Mission Opportunities Fund (LMOF): “To grant funding to assist in advancing human and Christian religious education in the Lasallian tradition, especially for the economically poor and socially marginalized, with specific emphasis on youth.”
- Describe the goals and objectives of the project, with particular emphasis on how it demonstrates a human and Christian Lasallian educational focus with emphasis on youth.
- Provide an itemized budget of expenditures for the usage of funds requested from the LMOF.
- Provide a timeframe for the initiation and duration for the expenditure of the funds from the LMOF.

- Provide a clear and objective method for evaluating the effectiveness of the project, including how these reflect the goals and objectives of the project.
- Is this grant intended to cover the total budget of the project? And how will the grant be applied to the project.
- Provide name and address or CUIT account information for the transfer of the grant if awarded.
- Submit a statement of endorsement from your sponsoring ministry supporting this project. If this request is from a Midwest District ministry, this statement is not necessary.
